



## FROST FIRE SKI AREA RELEASE WAIVER

### To be signed by parent/guardian if the participant is under 18 years of age.

I understand that as a condition of use of this ski area and other facilities, a customer or visitor assumes all risks of personal injury, death or property loss resulting from any cause whatsoever including but not limited to the risks, dangers, and hazards of skiing, snowboarding, tubing, cycling, hiking and all other recreational activities; the use of ski lifts, collision with natural and man-made objects or with skiers, snowboarders, tubers or other persons, travel within or beyond ski area boundaries; or negligence, breach of contract, or breach of statutory duty of care on the part of Frost Fire, Pembina Gorge Foundation and its representatives, agents, affiliates, partners, officers, directors, volunteers, independent contractors, subcontractors, sponsors, successors, and assigns (hereinafter collectively referred to as Frost Fire). The customer or visitor agrees that Frost Fire shall not be liable for any such personal injury, death, or property loss and releases Frost Fire and waives all claims with respect thereto. As a condition of my being permitted to ski, snowboard or tube or other recreational activities at Frost Fire, I agree to **ASSUME ANY AND ALL RISK OF INJURY OR DEATH, KNOWN OR UNKNOWN**, as well as damage to or loss of property which may be associated with Frost Fire, **REGARDLESS OF WHETHER THE DAMAGES, INJURY OR DEATH RESULT FROM RISKS INHERENT OR NOT.**

I understand that skiing, snowboarding, tubing is a sport that involves a certain amount of risk of injury, which can be minimized but not eliminated through the use of good equipment that is properly adjusted. The binding release values are set on the basis of a customer's provided height, weight, and skiing ability. The shop will exchange or readjust this equipment at any time free of charge, and **I WILL NOT MAKE ANY ADJUSTMENTS ON MY OWN.**

I understand that the releasable bindings furnished herewith are designed to reduce the risk or degree of injuries from falling and that **THESE BINDINGS WILL NOT RELEASE UNDER ALL CIRCUMSTANCES AND ARE NO GUARANTEE FOR MY SAFETY.** I furthermore release Frost Fire and/or any employee thereof from any liability for damage and injury to myself or to any other person or property resulting from use of this equipment, accepting myself the full responsibility for any and all such damage or injury.

I have carefully read and I understand this agreement and all of its terms. I understand that this is a release of liability and nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon me, my heirs, successors, assigns and legal representatives.
